ACADEMIC PARTNERSHIP AGREEMENT

Between

Ataturk University

Erzurum, Turkey

And

Founders of Jordan Medical Modern University

Amman, Jordan

- 1. This Academic Partnership Agreement (APA) was made on the 27/3/2018, Between: Ataturk University and the Founders of Jordan Medical Modern University (hereinafter called JMMU.
- 2. The purpose of this APA is to promote co-operation between Ataturk and JMMU to perform the following:-
 - 2.1. Establish a medical program in Medicine, Dentistry, Pharmacy, PharmD and Basic Medical Sciences that meet the agreed upon competencies.
 - 2.2. The JMMU will be obliged to develop a joint educational program in medical studies, or adopt the program hosted by Ataturk University.
 - 2.3. JMMU will invite the Ataturk University to participate in teaching and training.
 - 2.4. JMMU will invite the Ataturk University to act as the external examiner at certain times of the program.
 - 2.5. JMMU will put the logo of the Ataturk University on its website and certification granted to students.
 - 2.6. Ataturk University will develop a joint program and accredit the JMMU certification.
 - 2.7. Ataturk University will develop and accept internship students from JMMU.
 - 2.8. Ataturk University will provide faculty members for the purpose of the exchange between both organizations.
 - 2.9. Within the medical fields agreed upon, the following general forms of cooperation will also be pursued :-
 - Visits by and exchange of graduate students for study and research.
 - Visits by and interchange of staff for research, teaching and discussions.
 - Exchange of information.
 - Hold joint research activities.
 - Hold joint international conferences.

- Promote the profile of each University to the relevant student population in order to highlight international study opportunities
- 2.10. Intellectual party rights: rights of the intellectual properties would be taken into account, as the party's owned material.
- 2.11. Each party understands that any subsequent financial arrangements will have to be negotiated on an activity-by-activity basis, and will depend on the availability of funds. Specific details for the implementation of these activities will be developed mutually for specific projects. This APA will have, from time to time, annexes attached to it with regard to these specific projects, and any financial arrangements negotiated.
- 2.12. Each party will be responsible for its own actions, and the results arising from those actions should not be taken into account regarding the actions of the second party, and the results arising from such actions.
- 2.12. Activating this APA will begin from the date of signing, for a period of 5 years, and shall be automatically renewed unless termination is agreed upon by mutual consent of both parties, or by nine months' notice in writing of one party to the other party. Where the APA continues to be active, the two institutions agree to review it after five years from the date hereof.
