2. The receiving institution will send its decision within 4 weeks.
3. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

Description of the local grades:

The score 2.0 means that the knowledge of the subject is not sufficient. (0-65%)

The score 3.0 means that the knowledge of the subject is sufficient to pass a course. This grade is usually given when the examination/assessment results extend from about 66% to 73%

The score 3.5 means that the knowledge of the subject is quite good to pass a course. The grade is usually given when the examination/assessment results extend from about 74% to 80%.

The score 4.0 means that the student has a good knowledge of the subject. This grade is usually given when the examination/assessment results extend from about 81% to 86%.

The score 4.5 means that the student has a very good knowledge of the subject. This grade is usually given when the examination/assessment results extend from about 87% to 94%.

The score 5.0 means that the student has excellent knowledge of the subject. This grade is usually given when the examination/assessment results extend from about 95% to 100%.



