Proceeding from the common interest in the development of teaching and research at both universities and the endeavours to broaden the contacts between the universities, the University of Belgrade, Studentski trg 1, 11000 Belgrade, Serbia, represented by Rector Prof. Dr. Vladimir Bumbaširević and the T.C. Atatürk University, 25240 Erzurum, Turkey represented by Rector Prof. Dr. Ömer ÇOMAKLI (hereinafter referred to as "Universities") hereby conclude the following

AGREEMENT OF COOPERATION

Article 1

The Universities determine and regulate with this agreement the areas and matters of mutual cooperation as well as the forms and manners of its implementation.

Article 2

Cooperation will be undertaken, subject to availability of funds and the approval of the Universities through such activities or programs related to:

- 1. Exchange of research, teaching and administrative staff
- 2. Exchange of students of all levels,
- 3. Joint research activities
- 4. Participation in seminars and academic meetings
- 5. Special short-term academic programs
- 6. Professional Development Programs
- 7. Other areas in which concrete mutual interest in cooperation is established or will develop.

Article 3

Members of the Universities shall, on the basis of this Agreement, define the type, scope and principles of realization of this Agreement in an Annex to this Agreement.

Article 4

Each university shall designate a Liaison Officer to develop and coordinate the realization of specific activities or programs.

Article 5

The implementation of this agreement is dependent upon the availability of funds for joint activities.

All commitments, obligations and expenditures related to projects approved under this agreement shall be administered in accordance with each university's normal practices and policies and the specific terms and conditions of the funding agencies.

Article 6

By signing this Agreement the Universities assume no financial responsibility.

Article 7

Possible amendments and additions to this agreement shall be considered in writing and annexed to this agreement.

Article 8

The Universities agree that, if by reason of strike or other labor disputes, civil disorders, severe weather, Vis Major, or other unavoidable cause beyond the control of the university seeking to invoke this paragraph, either university is unable to perform its obligations, such non-performance shall not be considered a breach of this agreement.

Article 9

This agreement shall remain in force for a five (5) year period from the date of the last signature.

After the termination date as defined in the previous paragraph, this Agreement may be extended by mutual agreement in writing.

This agreement may be terminated by either university giving six (6) months written notice to the partner institution.

Article 10

This agreement shall go into effect when signed by the legal representatives of both Universities.

Article 11

This agreement has been drawn in 6 copy as originals, two (2) of them in Serbian, two (2) of them in English and two (2) of them in Turkish, all texts being equally valid.
